It is to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty, clinical material and stipend to PG students similar to PG students of government colleges in the state etc. throughout the

academic year, as stipulated in regulation of National Medical Commission (NMC).
